NOTICE: ALL PERSONS WITH AN ACTIVE real estate license and all licensed Entities such as Corporations, Partnerships and LLC's (hereafter referred to as licensees) must maintain a policy of professional liability (errors & omissions) insurance to maintain an active license.

Williams Underwriting Group is the program administrator for a professional liability (E&O) policy underwritten by National Union Fire Insurance Company of Pittsburgh, Pa., a member company of American International Group, Inc. (AIG). All licensees, including real estate firms, are eligible for this coverage. Williams Underwriting Group will certify individual licensee's compliance with the law directly to the Colorado real Estate Commission (CREC).

The E&O policy issued through our program provides the minimum CREC required limits of \$100,000/\$300,000 or your choice of limits as shown below. All limits are subject to a \$1,000 paid claim deductible per licensee.
